

Greetings Commissioners,

Once again, I would like to thank you for conducting hearings and listening to the voices of the people. On Tuesday, November 16th I had an opportunity to share my testimony regarding the importance of making Crown Heights North whole.

My name is Gail Muhammad and I am a lifelong resident of Crown Heights who has remained active in my community. I am the President of the 1200 Dean Street Block Association, Inc., 1st Vice Chair of Community Board 8 and Vice President of the Crown Heights North Association Inc. I have also had an opportunity to work with the Bedford Stuyvesant and Crown Heights Committee for Fair Redistricting. As a member of this group we developed a map that supported our goal of keeping Crown Heights North whole. The map that we drafted was previously submitted to the Independent Redistricting Committee for review.

More recently our group participated in a meeting that afforded us an opportunity to see the map proposed by the Unity Map Coalition. The Unity Map #30 does meet our goal of keeping Crown Heights North whole. We are in support of Unity Map # 30 with the following modifications

- Both the North and South side of Sterling Place be included to Kingston Avenue
- Southern border be extended to Lincoln Place (encumbering St. Johns Place)

After testifying about the aforementioned issues I was asked about the number of people who would be included in our proposed map Please note that the Unity Map #30 has a population of 137,980. Attached you will find a map that depicts the borders going South to Lincoln Place. The additional population addresses our modifications and are within the allowable 5% overage range, (see attachments)
