NOTICE OF PUBLIC HEARING

Pursuant to Article III, Section 4(c) of the New York State Constitution, the New York State Independent Redistricting Commission (the “Commission”) will hold a series of twelve public hearings across the state to receive feedback on its draft redistricting plan for court ordered New York State Assembly districts.

The Constitution requires the Commission to hold twelve hearings in the cities of Albany, Buffalo, Syracuse, Rochester, and White Plains, as well as the counties of Bronx, Kings, New York, Queens, Richmond, Nassau, and Suffolk.
